**STUDENT CONTRACT (SDA)**

KNOW ALL MEN BY THESE PRESENTS:

This AGREEMENT is made and entered by and between

ADVENTIST MEDICAL CENTER COLLEGE a non-stock corporation duly organized and existing under the Philippine laws, located at San Miguel, Iligan City, represented in this instance by PASTOR ROGER T. LOPEZ, Vice-President for Student Affairs and Services, hereinafter referred to as the FIRST PARTY, and \_\_\_\_\_ of legal age. Filipino, single/married and a resident of \_\_\_\_\_ Iligan City, hereinafter referred to as the SECOND PARTY.

**WITNESSETH**

That considering the fact that both the aforementioned parties have agreed freely and voluntarily entered into this Agreement they covenanted to be governed, ruled and bounded by the following terms and conditions.

1. That the SECOND PARTY understand clearly that Adventist Medical Center College is a private and religious institution. As such, the college orientation requires students to uphold the Seventh-day Adventist Church expectations.
2. That the SECOND PARTY clearly understands that any students who wishes to enroll in the Adventist Medical Center College must either submit to those rules or decide to go to other institutions.
3. That the SECOND PARTY pledges to follow the policies and standards of conduct for students at AMCC, and should in full harmony with the regulations and principles laid down by the government of the college.
4. That the SECOND PARTY agrees not to enter theatre or other questionable places of amusement, use tobacco or any harmful drug, drink liquor, violate the prescribe standard of attire and social relationship, carry or keep in his/her possession a firearm, or any kind of weapons, engage in fighting for any reason, be a member of a fraternity/sorority or any secret organizations or promote its activities while enrolled in AMCC.
5. That the SECOND PARTY promises to attend convocations, week of prayer and agrees to pay the fines if absent from the convocation and week of prayer.
6. That the SECOND PARTY being Seventh-day Adventist is required to attend 60% of the total number of religious meetings at the AMCC Church.
7. That the SECOND PARTY understand that failure to comply with No.6 would mean acceptance as a student for the following semester on the probationary status and, further, denial as the case maybe.
8. That the SECOND PARTY agrees to pay the yearbook as a official document of the college.
9. That the SECOND PARTY promise to obey the regulations of the college and cooperate in upholding each standard, as embodied in the student Handbook, and others, which maybe announced later.
10. That if at any time. SECOND PARTY is out of harmony with the regulation and standard of the school, he/she agrees to voluntarily withdraw; or allow the school to drop or dismiss him/her.
